**PRE-TRIAL AGREEMENT / STIPULATION FOR DEFERRED PROSECUTION
RE: NOTICE TO APPEAR / UNIFORM TRAFFIC CITATION / INFORMATION**

This matter comes before the Court upon stipulation between the State of Florida and the defendant to redirect this case into an alternative resolution/diversion program.

By entering into this agreement, the defendant agrees to waive his/her right to a speedy trial as provided for by F.R.C.P. 3.191. Further, by entering this agreement, the parties stipulate as follows:

1. It is agreed that this case shall be continued for the purpose of successfully completing all terms of this agreement by your next court date which is now scheduled for _____ / _____ / 20____ at _____: _____ AM / PM in Courtroom 2C.
2. It is agreed that if all conditions are successfully completed in a timely manner and the defendant has not been arrested for new charges, has not received any additional Notices to Appear or Uniform Traffic Citations, has not been convicted of any new crimes, abides by all pretrial release conditions and does not fail to appear, the State will abandon prosecution of this case.
3. Extensions of this agreement may be granted upon the discretion of the prosecutor.
