IRRIGATION CONNECTION DETAIL

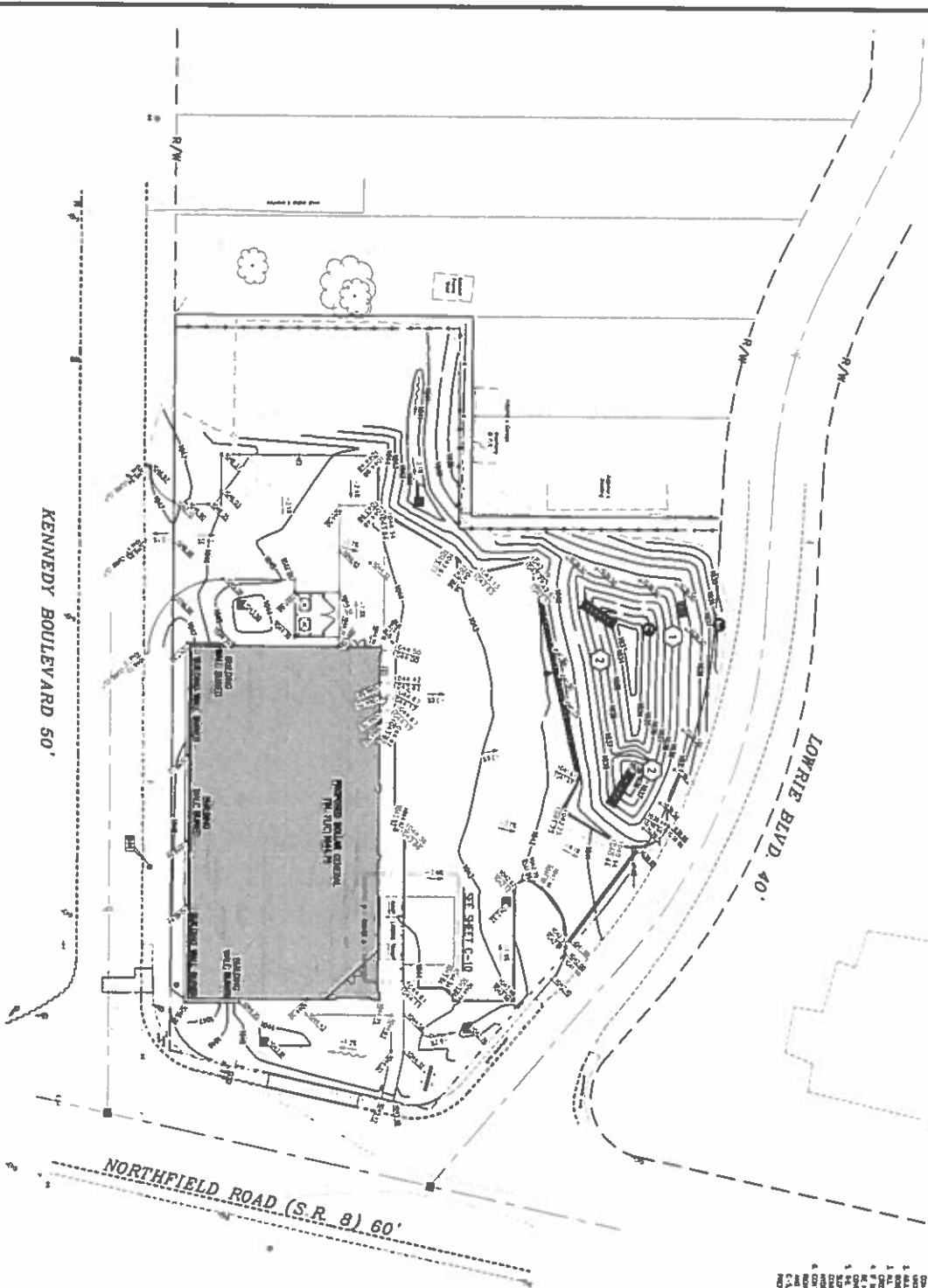
