#### OPEN FORUM

(slightly delayed) Cindy Palumbo, Olde Eight Road: She was concerned about the many trees slated to be removed (across Olde Eight from her property) in connection with the planned delivery station to be built between Dean Memorial Parkway, Hines Hill Rd, Olde Eight, and the Turnpike. She wanted more information on the plan for buffering for the adjacent residences, and noted that the entire project seemed to undercut the original goals of the Hines Hill Overlay. The Mayor stated that the plan was for the Olde Eight buffer to be about 100 feet wide and high enough, and with sufficient plantings, to fully shield the facility from view in that direction and along Hines Hill and much of Dean Memorial as well. Further discussion indicated that trees were likely to remain along the Turnpike border, but that pretty much all of the other existing forest was going to be removed. Councilor Janet Miller expressed her concern that many Village residents were unaware of the project and that it required more "transparency" on the part of the Village government. Some other discussion clarified that since the project did not involve a formal change of zoning (but rather some extensive variances), there was no occasion for an additional public meeting as with the various requests for rezoning the nearby hotel. It was noted that all meetings of the PC and BZA were also public meetings. The Mayor noted that there was much work yet to do on the site planning and that the Village Engineer's office would be reviewing such plans.

**A RESOLUTION DECLARING IT NECESSARY TO RENEW THE ROAD LEVY AT THE TAX RATE OF 2.75 MILL AND REQUESTING THE SUMMIT COUNTY FISCAL OFFICER TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE VILLAGE AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THIS RENEWAL LEVY, AND DECLARING AN EMERGENCY**

**WHEREAS**, this Council finds that the amount of taxes which may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of the Village and that it is necessary to levy a tax in excess of that limitation for the purposes of general construction, reconstruction, resurfacing and repair of streets, roads and bridges for the Village of Boston Heights under Section 5705.19(G) of the Ohio Revised Code; and,

**WHEREAS**, in accordance with Section 5705.03(B) of the Ohio Revised Code, in order to submit the question of a renewal tax levy pursuant to Section 5705.25 of the Ohio Revised Code, this Council must request that the Summit County Fiscal Officer certify (i) the total current valuation of the Village, and, (ii) the dollar amount of revenue that would be generated by the levy; and,

**WHEREAS**, in accordance with Section 5705.03(B) of the Ohio Revised Code, upon receipt of a certified copy of the resolution of this Council declaring the necessity of the tax, stating its purpose, stating whether it is an additional levy, a renewal or a replacement of an existing tax, noting the section of the Ohio Revised Code pursuant to which its submission to the electors is authorized, this Council desires to request the County Fiscal Officer to certify the total current tax valuation of the Village, and the dollar amount of revenue that would be generated by the proposed levy.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Boston Heights, Summit County, Ohio, two-thirds of the members elected therefore concurring that:

Section 1: This Council declares that it is necessary to have a renewal tax levied, for a period of five (5) years (i.e. 2022-2026), of 2.75 mills ad valorem property tax outside of the ten mill limitation for the purpose of general construction, reconstruction, resurfacing and repair of streets, roads and bridges within the Village of Boston Heights under Section 5705.19(G) of the Ohio Revised Code, and that it intends to submit the question of the renewal of the levy to the electors at an election on November 2, 2021, as authorized by the Ohio Revised Code.

Section 2: This Council requests that the Summit County Fiscal Officer certify to both (i) the total current tax valuation of the Village, and, (ii) the dollar amount of revenue that would be generated by the 2.75 mill renewal levy specified in Section 1.



Section 3: The territory covered by the proposed levy is only that within the corporate limits of the Village of Boston Heights, Summit County, Ohio. Boston Heights does not have territory outside of said county.

Section 4: The proposed levy would be placed on the tax list, i.e. be levied, beginning in 2022 for the first collection in 2023, if the electors voting on it approve the levy as provided by law.

Section 5: The proposed levy would be levied and remain in effect for five years, i.e. 2022, 2023, 2024, 2025 and 2026. The levy shall be collected during 2023, 2024, 2025, 2026 and 2027.

Section 6: The Village Fiscal Officer is authorized and directed to deliver to the Summit County Fiscal Officer, no later than one week after passage, a certified copy of this Resolution and the form of the County Fiscal Officer's Certificate in connection therewith that is currently on file with the Clerk of Council.

Section 7: That all Resolutions and Ordinances which are in conflict with this Resolution are hereby replaced and/or rescinded to the extent they conflict.

Section 8: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 9: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 404 during the state-declared COVID-19 emergency.

Section 10: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare of the Village's resident and to comply with the strict timing requirements of the Ohio Revised Code regarding the levying of taxes outside the 10 mill limitations and shall take effect and be in force from and immediately after its passage.

**A RESOLUTION TO AWARD THE BRANDYWINE ROAD PHASE 1 CONTRACT TO  
PERRIN ASPHALT AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Boston Heights previously advertised for bids for the Village's Brandywine Road Phase 1 project (the "Improvement"), which is a part of the Village's previously adopted Capital Improvement Program; and,

**WHEREAS**, the Mayor and the Village Engineer have reviewed the bids for the Improvement and Perrin Asphalt (the "Contractor") has been determined to be the lowest and best bidder for the Improvement as evidenced in Exhibit "A;" and,

**WHEREAS**, in order to timely proceed with this Improvement, the Mayor hereby requests authorization from the Council of the Village to award a contract to the Contractor

**NOW, THEREFORE, BE IT RESOLVED** by Council of the Village of Boston Heights, Summit County, Ohio, as follows:

Section 1: That Council received six (6) submissions from qualified contractors after the public bidding process.

Section 2: That the contractors submitting qualifications have been evaluated and that Perrin Asphalt had the lowest and best bid and is otherwise considered and is found to be the most qualified, as set forth in Exhibit "A."

Section 3: That the Mayor is hereby authorized and directed to negotiate and enter a contract with Perrin Asphalt, the contractor most qualified to perform the required services, for the improvement at a compensation determined in writing to be fair and reasonable.

Section 4: That the contract negotiations by the Mayor with the selected Contractor will be directed toward:

- (A) Ensuring that the Contractor and the Village have a mutual understanding of the essential requirements involved in providing the required services;
- (B) Determining that the Contractor will make available the necessary personnel, equipment, and facilities to perform the services within the required time; and,
- (C) Agreeing upon compensation which is fair and reasonable, taking into account the estimated value, scope, complexity and nature of the services.

Section 5: That Village Council hereby awards a contract to Perrin Asphalt for the Village's Brandywine Road Phase 1 project in an amount not to exceed \$410,000.00.

Section 6: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 7: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 404 during the state-declared COVID-19 emergency.

**WHEREAS**, the Village of Boston Heights desires to engage OHM Advisors to render certain services with regard to the evaluation of all 21 miles of Village street using the ODOT Pavement Condition Rating and compiling the data into an interactive GIS tool within the Village; and,

**WHEREAS**, OHM Advisors is willing to provide said services for the consideration upon the terms and conditions of an Agreement, substantially similar to the one attached hereto as Exhibit A; and,

**WHEREAS**, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the Village to collaborate with the OHM Advisors as to the evaluation of the Village's streets and compiling of such data.
