Sealed bids will be received by the Engineer of the Village of Northfield, Summit County, Ohio at the Carmen A. Consolo Public Service Center, 199 Ledge Road, Northfield, Ohio 44067, until 12:00 P.M., local time on May 6, 2021 and at that time and place will be publicly opened and read aloud for the following Contract:

JEFFERSON DRIVE DRAINAGE & PAVEMENT IMPROVEMENTS

Copies of the Contract Documents, Plans and Specifications are on file and may be examined at the office of the Village Engineer at 199 Ledge Road, Northfield, Ohio 44067. Copies of the Contract Documents, Plans and Specifications may be obtained from the Villager Engineer's office at a cost of Fifty Dollars (\$50.00) for each set. Payment will be required in advance. Checks are non-refundable and shall be made payable to The Village of Northfield.

The work to be performed under this contract consists of furnishing all labor, equipment, tools, materials and incidentals required for the full removal and replacement of approximately 122 feet of Jefferson Drive & Monroe Drive of a 15-inch depth of approximately 340 square yards of asphalt pavement including a new pavement section consisting of 6" aggregate base, 6" asphalt concrete base, 1-3/4 inch thickness of asphalt intermediate course and 1-1/4 inch thickness of asphalt surface course. Approximately 244 feet of concrete curb removal and replacement is required. Approximately 1,321 square yards of sports court asphalt pavement to a depth of 4-inches is being removed. Four street catch basins are being removed and replaced along with the addition of 160 feet of 24" storm sewer and 2 new precast storm manholes.

All bidders shall include the Bid Form and entire Contract Document booklet along with any addenda, in their entirety and original form with his/her bid. All bidding documents shall be obtained from the offices of the Village Engineer. Duplicates of the Bid Form and Contract Documents will be considered unacceptable.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation currently licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar nature, size and complexity. The Village of Northfield intends and requires that this project be completed within 90 days after the issued Notice to Proceed.

Bidders shall comply with the State of Ohio prevailing wage rates on Public Improvements in Summit County and Northfield, Ohio as determined by the Ohio Department of Commerce, Wage and Hour Division.
