### CITY OF MACEDONIA RESOLUTION NO. <u>34</u> -2021

### A RESOLUTION CONFIRMING THE CONDITIONAL USE ZONING CERTIFICATE AS APPROVED BY THE CITY OF MACEDONIA PLANNING COMMISSION IN REGARD TO PHASES III & IV OF THE SPRUCE HILL CROSSING PLANNED UNIT DEVELOPMENT PROJECT, AND PARTIALLY WAIVING THE REQUIREMENT FOR THE CONSTRUCTION OF SIDEWALKS

WHEREAS, Planned unit developments, a residential use, are considered a permitted use in R-1 residential districts when approved by the City of Macedonia Planning Commission as a conditional use; and

WHEREAS, the Planning Commission previously approved the proposed Spruce Hill Crossings planned unit development project as a conditional use in a residential district at its April 16, 2019 Planning Commission meeting, which was previously confirmed by the City through Ordinance 38-2019, which approval has since expired with the passage of time and lack of development; and

**WHEREAS**, as part of Ordinance 38-2019, Council also issued a limited waiver as of the required sidewalks as set forth in the document attached as Exhibit "A" and incorporated herein by reference, which has likewise since expired.

WHEREAS, and the Planning Commission has determined a conditional zoning certificate for Spruce Hill Crossing Phases III & IV is proper and has approved the same at its March 15, 2021 Planning Commission meeting, immediately following a public hearing for the same, and has further recommended at that Planning Commission meeting that the requirement of the construction of sidewalks in regard to Phases III & IV of the Spruce Hill Crossing planned unit development project be waived, pursuant to Macedonia Codified Ordinance 1163.05(h)(2), as set forth in the document attached hereto as Exhibit "B" and incorporated herein by reference; and

WHEREAS, Council therefore wishes to confirm the issuance of said conditional zoning certificate relative to Phases III & IV of the Spruce Hill Crossing planned unit development project, and confirm a limited waiver of the requirement for the construction of sidewalks for said phases.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Macedonia, County of Summit and State of Ohio:

<u>Section 1</u>. That the conditional zoning certificate issued by the Planning Commission is herein confirmed, contingent upon all recommendations and requirements imposed by the Planning Commission being adhered to, and that the requirement for the construction of sidewalks be in part waived relative to Phases III & IV of the Spruce Hill Crossing planned unit development project in accordance with the installation of sidewalks as depicted in Exhibit "A."

<u>Section 2</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.



### MACEDONIA PLANNING COMMISSION MARCH 15, 2021 VIRTUAL MEETING MINUTES

CALL TO ORDER: Mr. Westbrooks called the meeting to order at approximately 5:30 p.m.

#### **MEMBERS PRESENT:**

Planning Commission: Mr. Westbrooks, Mr. Schiavone, Mr. Roberts, Mr. Cox, and Mr. Velotta. Mayor: Nick Molnar City Planner: Brian Frantz City Engineer: Joe Gigliotti Building Commissioner: Bob Rodic

APPROVAL OF THE FEBRUARY 8, 2021 PLANNING COMMISSION MEETING MINUTES. Mr. Cox motioned to approve, Mr. Schiavone seconded, Mr. Roberts agreed. Mr. Westbrooks abstained.

## PROPOSED ZONING CERTIFICATE APPROVAL TO PERMIT A PLANNED UNIT DEVELOPMENT WITH-IN THE R1 ZONING DISTRICT LOCATED AT SPRUCE HILL DEVELOPMENT.

Mr. Coblentz with Coblentz homes was present and commented that the proposals for the Zoning Certificate and the final site plan have already been approved but were delayed due to covid and is asking for re approval for the zoning certificate and the preliminary/final site plan adding that it be split into phase III & IV. Mr. Frantz made his comments and recommended approval of the Conditional Zoning Certificate. He stated that it does require Council approval per section 1163.05 in the code. Mr. Coblentz stated that he is planning to use the existing covenants and restrictions that are in place for the first phase of the development, but they do have to be set forth through the commission as part of the record for preliminary and final approval and would have to be recorded. Mr. Gigliotti made his comments. Mr. Westbrooks questioned the sidewalks and the plan proposed. There was discussion of how much sidewalk and where it would start and end. Mr. Coblentz commented that there would probably be landscaping up to the corner, it would look better to have the landscaping vs a sidewalk to nowhere. Mr. cox commented that they could waive the sidewalk all over again and send it back to Council. Mr. Schiavone agreed with Mr. Cox. Mr. Westbrooks stated that they agreed to the pavers for the emergency access drive and Mr. Coblentz stated that they had it as gravel but would have no objections to permeable, asphalt or concrete per Mr. Gigliotti's recommendation. Mr. Westbrooks commented that a lighting plan could be approved administratively and that he would like the more decorative lighting. Mr. Coblentz commented he would like to be consistent with the rest of the development. Mr. Westbrooks motioned to approve the Conditional Zoning Certificate for the Spruce Hill Crossings Development Phase III & IV, Mr. Cox seconded, and all were in favor.

# PROPOSED PRELIMINARY AND FINAL SITE PLAN APPROVAL FOR PHASE III & IV OF SPRUCE HILL CROSSINGS DEVELOPMENT.

Mr. Coblentz and Mr. Barcikosky were present. Mr. Westbrooks motioned to approve the preliminary/ final site plan for phase III & IV of Spruce Hill Crossings Development subject to the Covenants and Restrictions being submitted to the City for approval, the final lighting and landscaping plans are submitted for admin approval. Permeable pavers, asphalt, or concrete is used for emergency access, sidewalks are waived pursuant to the site plan submitted on dated February 17, 2021 in the new phases. Mr. Schiavone seconded, and all were in favor.

# PROPOSED CONDITIONAL USE APPROVAL FOR NEW STORAGE BUILDINGS IN A GENERAL INDUSTRIAL DISTRICT.

Joseph Krash and Laurie Haas were present. Mr. Krash gave an overview of his proposal. Mr. Frantz made his comments. There was discussion of outdoor storage. Mr. Krash stated that if outdoor storage is needed in the future, they would ask for approval and it is not necessary at this time. Mr. Frantz questioned the landscaping and commented that more landscaping should be added. There was discussion of the parking. Mr. Krash commented that with this type of site the buildings themselves are the parking spaces, that cars are stored in the buildings. Typically, there are not many cars parked outside of the garage, and the plan says gravel parking spaces, but he was planning on asphalting the areas around the buildings. Mr. Westbrooks stated that if the parking lot were asphalted that the parking would be accommodated. Mr. Gigliotti made his comments. There was discussion of the fence and the detention basin. Mr. Frantz suggested that a gate could be added inside the property for maintenance purposes and that some landscaping in front of pond could be done. Mr. Westbrooks motioned to approve the Conditional Zoning Certificate with the stipulation of no outdoor storage based on the February 10, 2021 site plan and the 500 ft min distance to residential home, pursuant to 1171.18 (C) in the code is acceptable. Mr. Cox seconded, and all were in favor.

# PROPOSED APPROVAL OF PRELIMINARY SITE PLAN FOR FOUR NEW STORAGE BUILDINGS LOCATED AT PARCEL # 33-03015 FOR SPACE PLACE.

Mr. Westbrooks motioned to approve the preliminary site plans contingent upon applicant's testimony that they will pave instead of gravel the land banked parking areas and fencing gate access to be internal from the site to the pond and fence along freeway drive be removed and all the remaining comments from the City Engineer and City Planner will be addressed prior to final approval. Mr. Cox seconded, and all were in favor.

### PROPOSED CONDITIONAL USE APPROVAL FOR A DEO BUILDING REPLACEMENT LOCATED AT 1091 E. AURORA RD. & ALEXANDRIA WAY.


Eray Tulay, Andrew Lonneman and Michael Antonius with Dominion Energy were present and presented their proposal. Mr. Tulay stated that the original plan was approved in 2019 but before proceeding they realized they would like to add a valve header to the original plan. Mr. Frantz made his comments. There was discussion of the barbed wire on the fence and landscaping. Mr. Frantz recommended a powder coating the fence. Mr. Roberts asked if the valve header is being replaced or are, they adding something or trying to solve a problem? Mr. Tulay replied, it is a new improvement and will benefit the residents and the station will always be in service. Mr. Westbrooks motioned to approve the Conditional Use, Mr. Roberts seconded, and all were in favor.

# PROPOSED DOMINION ENERGY STATION REPLACEMENT AND VALVE HEADER ADDITON LOCATED AT 1091 E. AURORA RD. & ALEXANDRIA WAY.

Mr. Westbrooks motioned to approve the final site plan on the condition that Dominion comes back with a final landscaping to be administratively approved and to work out the fence details administratively. Mr. Roberts seconded, and all were in favor.

### CITY OF MACEDONIA ORDINANCE NO. <u>35</u> -2021

### AN ORDINANCE AMENDING SECTION 161.10 OF THE CODIFIED ORDINANCES OF THE CITY OF MACEDONIA RELATIVE TO CERTAIN BENEFITS RELATED TO NON-UNION SAFETY FORCE COMMAND STAFF

WHEREAS, it is necessary and in the best interest of the health, safety and welfare of City residents to amend Section 161.10 of the Codified Ordinances of the City of Macedonia relative to certain benefits provided to the non-union command staff for the City of Macedonia Police Department and Fire Department.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Macedonia, County of Summit and State of Ohio:

Section 1. That Section 161.10 of the Codified Ordinances of the City of Macedonia shall be amended to read as set forth below:

### 161.10 SICK LEAVE.

(h) <u>Retirement/Termination of Employment.</u>

(1) <u>Retirement/death.</u> An employee, at the time of retirement or disability retirement from active service with the Municipality, or at his/her death, shall be paid in cash, forty percent (40%) of the value of his accrued but unused sick leave credit to a limit of a maximum of forty-eight days (384 hours). Such payment shall be based on the employee's rate of payment at the time of retirement or death, and shall be made only once to an employee or his/her heirs.

As used in this section, "retirement" is defined as "disability or service retirement under any State or municipal retirement system in this State."

(2) <u>Service retirement.</u> An employee, <u>other than Safety Force Command Staff</u>, who has a combined service credit of ten years or more with any state, county or local subdivision and is anticipating early "retirement", will be entitled to cash out forty percent (40%) of their accrued but unused sick leave, to a limit of a maximum of 48 days (384 hours), only for sick leave accumulated while employed by the City of Macedonia. <u>Safety</u> Force Command Staff shall be entitled to cash out the percentage of their accrued but unused sick leave, as set forth in any collective bargaining agreement entered into with a bargaining unit within their respective departments. An employee shall receive payment under this section with the understanding that his/her records will indicate such and that, in the event of reemployment with another public entity, there will be no accrued sick leave for purposes of transfer to the other agency.

As used in this section and sections (j) and (l) below, "Safety Force Command Staff" is defined to include the Police Chief and Fire Chief as well as the Police Lieutenant and Assistant Fire Chief so long as those positions remain outside of any collective bargaining unit.

\*\*\*

(j) <u>Sick Leave Incentive.</u> Any full-time employee who does not use any sick leave within a calendar quarter, shall receive four hours of compensatory time for that quarter, except that Safety Force Command Staff shall receive the number of hours of compensatory time for that quarter as set forth in any collective bargaining agreement entered into with a bargaining unit within their respective departments.

(l) <u>Sick Leave Carryover Options</u>. With approval of the Mayor, a full-time or part-time employee who is credited with sick leave, may elect one of the following options with respect to sick leave credit of over 960 hours remaining at the end of a year:

(1) Carry forward the balance.

(2) Receive a cash benefit. Except for Safety Force Command Staff, the cash benefit shall equal .4 hour of the employee's base rate of pay for every one hour of unused credit that is converted. The balance of unused sick leave shall not go below the 960 hour limit. The maximum number of hours which can be "cashed out" will not exceed 100 hours per year. Safety Force Command Staff shall be entitled to receive a cash benefit and maximum hours equal to that set forth in any collective bargaining agreement entered into with a bargaining unit within their respective departments.

<u>Section 2</u>. That the remainder of the Codified Ordinances of the City of Macedonia shall not be amended unless inconsistent with this Ordinance.

<u>Section 3</u>. The Clerk of Council is authorized and directed to forward a certified copy of this Ordinance to the Codifier of the City of Macedonia.

<u>Section 4</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

<u>Section 5</u>. Wherefore, this Ordinance shall become effective upon its adoption by Council and signature of the Mayor or as otherwise be provided for in law.

### AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT FOR THE PURCHASE AND INSTALLATION OF A VIDEO CAMERA SECURITY SYSTEM FOR THE CITY OF MACEDONIA

**WHEREAS**, the City of Macedonia's current video camera security system is outdated, obsolete, broken and therefore in need of replacement; and

WHEREAS, the City of Macedonia desires to purchase a new video camera security system, with installation, configuration and three years of licensing and support, at the anticipated cost of \$50,623.21 by entering into an agreement with Turnkey Technologies through the National Cooperative Purchasing Alliance ("NCPA") cooperative purchasing program, Contract #01-86 at the recommendation of the Information Technology Director; and

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of Council, and of any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
